

Terms and Conditions for Participation

 Top Spender Rewards May 2021 (hereinafter called "Promotion") is held from 12 May – 30 May 2021 (both days inclusive, hereinafter called "Promotional Period") in ifc mall (hereinafter called "ifc"). CLUB ic Members (hereinafter called "Members") are eligible to participate in the Promotion.

Terms and Conditions for Member(s)

- 2. The top 30 members who have accumulated eligible spending across all categories at ifc mall within Promotional Period, are entitled to receive ONE designated designer handbag (valued at: HK\$31,500 to HK\$34,500).
- Eligible Transaction Period will be between <u>12 May and 30 May 2021</u> (both days inclusive). The spending must be registered and confirmed by CLUB ic <u>by 6 June 2021</u>.
- 4. Only transactions settled by electronic payment (credit card, debit card or EPS) will be entitled to participate in this Promotion. More than one transaction on the same day are accepted. The registered member name must be the same as the one stated on the related electronic payment slips. Spending in Apple Store, telecommunications services, banking and currency exchange services, car parks, Four Seasons Hotel, Four Seasons Place, store credits, purchase of cash and gift vouchers, store-value cards, any value added to storevalue cards and online purchases are not eligible for participating in the Promotion.
- 5. The amount of Eligible Spending is based on the net spending amount, which is the final amount charged to the payment card as shown on the electronic payment slip. The use of any discount offers, cash rebate and any forms of credit card rebate dollars like cash dollars will not be taken into account. For a transaction with a balance payment to be settled, only the deposit payment settled will be eligible for the registration.
- 6. For deposit receipts, detailed transaction particulars must be displayed including the corresponding merchandise information, deposit and balance payment information and unique serial number etc. The transaction(s) will be deemed as purchase of gift card if the corresponding information is not available on the receipt(s) and will be ineligible for membership registration and Gift and vouchers redemption.
- 7. The deposit and remaining balance settlement will be deemed as one transaction. Each eligible transaction can be registered once and by the same CLUB ic member only. Multiple registrations of the same transaction or by more than one member are not eligible. The deposit and remaining balance of each eligible transaction must be settled by the same member, and only the primary payer will be identified as the one to complete the transaction. If found re-application and/or multiple registrations, the corresponding transaction and/or redeemed gift will be retrieved and cancelled.
- 8. If the deposit receipt is used for gift redemption in any previous promotions (including but not limited to CLUB ic Flash Instant Rebate in 2020 May & June, July & Autumn Rewards 2020, Xmas Redemption Programme 2020, CNY Redemption Programme 2021 and Spring/Summer Redemption Programme 2021), the corresponding balance settlement cannot be used for gift redemption in this Promotion.
- 9. The eligible spending of a Master Member and Affiliated Member is counted individually.



- 10. Valid receipts will be stamped by International Finance Centre Management Co., Ltd. (hereinafter called "ifc") authorised chop after ifc Points registration. Receipts that are not registered by 6 June 2021 will be regarded as invalid. Out-dated receipt(s), duplicate receipt(s), re-printed receipt(s), damaged receipt(s) and photocopied receipt(s) are not acceptable. No receipt is allowed to be re-used for Reward in the Promotion.
- Member(s) must register ifc Points at CLUB ic Lobby located at U2, One International Finance Centre (Service hours: 10am 8pm daily) or in-mall Concierge on Podium Level 1 (near LANCÔME, Shop 1090) (Service hours: 9:30am 9:30pm daily) within the Promotional Period.
- 12. All receipts presented for redemption of the Reward will not be eligible for refund. Any refund requests where receipts have been stamped by ifc will be rejected. The amount of ifc Points earned from the registered receipts will be deducted if the concerned receipts have been refunded.
- 13. Each eligible member is entitled to receive ONE gift. The Gift is assigned based on the accumulated spending amount within Promotional Period. Selection of style and colour is not permitted. Individual notification will be sent to members with eligible spending qualified for the gift redemption from 9 June 2021.
- 14. Gift redemption will be available from 9 June to 30 June 2021. Member(s) are obligated to inspect the Gift before redemption. Redeemed Gift cannot be returned, replaced or exchanged. Gift cannot be redeemed for cash, or for other gift vouchers, store credits, products or services.
- 15. Eligible members must redeem the Gift in person at the designated venue by presenting their CLUB ic membership card and the SMS notification on or before 30 June 2021. Members can contact CLUB ic and authorize a representative to collect the Gift on their behalf. Authorized persons must present their identity card for verification upon gift redemption.
- 16. ifc reserves the right not to accept and/or recognise any spending(s) which are deemed inappropriate, suspicious and/or invalid for registration in the Promotion at its sole and absolute discretion. For any cases or suspected cases of dishonesty, ifc reserves the right to seek assistance from the police.
- 17. Sales personnel of mall tenants are not allowed to join this Promotion or join on behalf of Member(s).
- 18. The Promotion is bounded by the above terms and conditions. ifc reserves the right to cancel, revise or suspend all or any part(s) of the Promotion, or the terms and conditions herein contained, at any time without prior notice.
- 19. The decision of ifc on all matters relating to, or in connection with, the Promotion shall be final and binding on all parties concerned.
- 20. In case of discrepancies between the English and Chinese versions of these terms and conditions, the English version shall prevail.
