

## ifc mall "The Phoenix's Celestial Court" Chinese New Year Art Installation 2026

### Terms and Conditions for Participation

1. "The Phoenix's Celestial Court" Chinese New Year art installation ("Event") is held from 5 February 2026 to 3 March 2026 and is hosted by International Finance Centre Management Co., Ltd. ("ifc").
2. By participating in the Event, shoppers ("Participants") agree to comply with and be bound by the corresponding terms and conditions.
3. Children aged 12 or below must be accompanied and supervised by an adult at all times inside the Event premises.
4. The Event will be temporarily closed when there is a performance or private event. Opening hours are subject to change without prior notice.
5. ifc may, without prior notice and without compensation, change the operating hours of the Event, close it temporarily or permanently, and/or restrict the number of Participants with access to the Event, due to capacity, equipment maintenance, or if ifc considers that the circumstances so require.
6. Participants should not damage the installations, exhibits, or facilities of the interactive mechanical and digital experiences. Any damage to the installations, exhibits or facilities of the interactive mechanical and digital experiences should be reported immediately to the staff. Participants may be held responsible for any damage made.
7. Participants must abide by the Terms and Conditions for Participation and instructions advised by the staff at the mall.
8. Participants are responsible for their personal belongings. ifc does not take any responsibility for loss of personal belongings.
9. Participants are responsible for their own physical and mental conditions. Participants experiencing any discomfort should refrain from participating in the Event and notify the mall staff for assistance if needed.
10. In case of huge crowd, the mall staff may have corresponding arrangement on traffic control, including but not limited to the admission and duration. Participants must follow the instructions of the staff on the on-site arrangement.
11. The Event is thoroughly cleaned and disinfected regularly.
12. No food or drink is allowed at the Event premises.
13. Pets including dogs and cats are welcome on the Event premises. Pets must be securely hand-carried by their owners, kept in their own pet stroller or pet carrier. For detailed information about our pet policies, please refer to ifc mall's website: <https://ifc.com.hk/en/pet-policy/>.
14. For pet owners who fail to comply with the above guidelines, ifc reserves the right to deny admission, or to require a participant already admitted to leave the site. In case of disturbance or accidents caused by their pets, pet owners are liable to the concerned parties and will be responsible for all medical and other expenses related to the accident.
15. In case of any act of God or other unforeseen circumstances, including Black Rainstorm and Tropical Cyclone Warning Signal No. 8 or above, the operating hours of the Event may be changed temporarily.
  - 15.1. When the Tropical Cyclone Pre-No. 8 Special Announcement or Warning Signal No. 8 or above is issued: The Event will be closed and cancelled immediately. If the signal is lowered or cancelled by the Hong Kong Observatory on or before 16:00, the Event will resume operation in 2 hours. If the signal is lowered or cancelled after 16:00, the Event will be closed for the day.
  - 15.2. When the Black Rainstorm Warning Signal is issued: If the signal is issued during Event hours, it will remain in normal operation. If the signal is issued before the Event opens, the Event will remain closed. If the signal is lowered or cancelled by the Hong Kong Observatory before or at 16:00, the Event will

resume operation in 2 hours. If the signal is lowered or cancelled after 16:00, the Event will be closed for the day.

16. These terms and conditions set out the guidelines for the Event to ensure all the Participants shall have a fair opportunity to access and enjoy the Event.
17. For Participants who fail to comply with the above guidelines, ifc reserves the right to deny admission or to require a participant already admitted to leave the site.
18. By participating in the Event, Interactive Experiences and Interactive Digital Experience, participants are playing at their own risk and disclaim ifc (and its employees) from responsibility as a result of any injury from any accident connected with the Event, Interactive Experiences and Interactive Digital Experience.
19. In case of any dispute, ifc reserves the right of final decision, including the right to suspend, change or terminate the Event and of its terms and conditions without prior notice.
20. In case of discrepancies between the English and Chinese versions of these terms and conditions, the English version shall prevail.

#### **Interactive Experience at “Spinning Petals” and “Birds of Prosperity”**

21. Each participant is entitled to participate in one round of the Interactive Experience at a time.
22. Participants are only allowed to lightly turn the “Spinning Petals” or the handle of the “Birds of Prosperity” to trigger the interactive effects according to on-site instructions at the Event.

#### **Interactive Digital Experience at “Wishful Wings”**

23. Only one participant is allowed to take part in the Interactive Digital Experience at a time.
24. Each participant is entitled to one experience daily.
25. Each participant can receive a printed copy of their Wish Weaver Stickers and/or a digital copy for each participation.
26. Limited daily quotas apply to the printed copies of Wish Weaver Stickers and are available on a first come, first served basis, while stocks last. Only digital copies will be available for download if the daily quota of printed copies is fully redeemed, without prior notice.
27. Participants are only allowed to lightly press the digital screen to experience the game according to on-site instructions at the Event.
28. Participants can use their internet-connected personal smartphones or mobile devices to scan the QR code shown on screen to download a digital copy of their Wish Weaver Stickers .
29. Downloading the digital copy of the Wish Weaver Stickers requires the use of mobile data or a wireless network connection. The mobile network provider of participant may charge for data usage. Participants are advised to inquire with their mobile network provider for details. ifc will not be responsible for any such charges. Free Wi-Fi is available within the ifc mall, and participants agree to the terms and conditions for using the free Wi-Fi to access the mall's Wi-Fi network.
30. Any lost or damaged printed copy will not be redistributed.
