

ifc mall "Summer Pool Party by Cj Hendry" Art Installation 2025

General Terms and Conditions for Participation

- 1. The "Summer Pool Party by Cj Hendry" ("Event") is held from 17 July to 24 August 2025 and is hosted by International Finance Centre Management Co., Ltd. ("ifc").
- 2. By participating in the Event, shoppers ("Participants") agree to comply with and be bound by the corresponding terms and conditions. Participants must abide by the on-site safety rules and instructions advised by our staff.
- 3. Children aged 12 or below must be accompanied and supervised by an adult (aged 18 or above) at all times at the event premises.
- 4. The Event will be temporarily closed when there is a performance or private event. Opening hours are subject to change without prior notice.
- 5. ifc may, without prior notice and without compensation, change the operating hours of the Event, close it temporarily or permanently, and/or restrict the number of Participants with access to the event, due to capacity, equipment maintenance, or if ifc considers that the circumstances so require.
- 6. Participants should not damage the installations, exhibits, facilities of the digital experiences. Any damage to the installations, exhibits or facilities of the digital experiences should be reported immediately to the staff. Participants may be held responsible for any damage made.
- 7. Participants are responsible for their personal belongings. ifc does not take any responsibility for loss of personal belongings.
- 8. Participants are responsible for their own physical and mental conditions. Participants experiencing any discomfort should refrain from taking part in the event and notify on-site staff for assistance if needed.
- 9. In case of huge crowd, staff on duty may have corresponding arrangement on traffic control including but not limited to the admission and duration. Participants must follow the instructions of the staff on the on-site arrangement.
- 10. Limited quotas apply and all souvenir(s) are available on a first come, first served basis, while stocks last. Souvenir(s) cannot be exchanged, returned or exchanged for cash.
- 11. Souvenir(s) are provided by third-party suppliers. ifc shall not be legally liable for (including but not limited to) the quality of such souvenir(s); nor guarantee nor be responsible for the consequences arising from the use of souvenir(s).
- 12. The Event is thoroughly cleaned and disinfected regularly.
- 13. The consumption of food or drink are prohibited at the Event premises.
- 14. All pets must be securely placed in pet strollers, bags or held in arms when entering the designated Event premises. Guide dogs and dogs in connection with the exercise of a lawful power are exempted from this restriction.
- 15. Pets should not be left unattended under any circumstances.



- 16. Pet owners are solely responsible for any injuries to their pets, as well as any injuries, damage to or loss of property or belongings of others. ifc shall not be held responsible or assume liability for any such incidents, whether caused by ifc or otherwise. If a pet owner's pet causes inconvenience or accidents to others, the pet owner shall take responsibility for the consequences and must bear all medical and other costs related to the incident. For pet owners who fail to comply with the above guidelines, ifc reserves the right to deny admission, or to require a participant already admitted to leave the site.
- 17. In case of any act of God or other unforeseen circumstances, including Black Rainstorm and Tropical Cyclone Warning Signal No. 8 or above, the operating hours of the Event may be changed temporarily.
 - 1. When the Tropical Cyclone Pre-No. 8 Special Announcement or Warning Signal No. 8 or above is issued: The Event will be closed and cancelled immediately. If the signal is lowered or cancelled by the Hong Kong Observatory on or before 16:00, the Event will resume operation in 2 hours. If the signal is lowered or cancelled after 16:00, the Event will be closed for the day.
 - 2. When the Black Rainstorm Warning Signal is issued: If the signal is issued during Event hours, it will remain in normal operation. If the signal is issued before the Event opens, the Event will remain closed. If the signal is lowered or cancelled by the Hong Kong Observatory before or at 16:00, the Event will resume operation in 2 hours. If the signal is lowered or cancelled after 16:00, the Event will be closed for the day.
- 18. These terms and conditions set out the guidelines for the Event to ensure all the Participants shall have a fair opportunity to access and enjoy the Event.
- 19. For Participants who fail to comply with these terms and conditions, ifc reserves the right to deny admission, or to require an already admitted participant to leave the site.
- 20. By participating in the event and the experience, you are playing at your risk and disclaim ifc (and its employees) from responsibility as a result of any injury from any accident connected with the experience.
- 21. In case of any dispute, ifc reserves the right of final decision, including the right to suspend, change or terminate the Event and of its terms and conditions without prior notice.
- 22. In case of discrepancies between the English and Chinese versions of these terms and conditions, the English version shall prevail.

Terms and Conditions for "Blooming Summer Pool"

- 23. The minimum height requirement of entering the Blooming Summer Pool ("Pool") is 100 cm. Participants who do not meet the height requirement are not allowed to enter the Pool due to safety reasons.
- 24. Each Pool session lasts for 15 minutes and starts at 00, 20, and 40 minutes past the hour from 11:00 to 21:00 during the Event Period (except timeslots between 15:40 and 16:20).
- 25. Same-day queue tickets are available for distribution daily at the Pool entrance in the Event premises for the Pool experience and Joyful Slide ("Slide") experience. Tickets are distributed starting at 10:30 for time slots between 11:00 and 15:40, and again at 15:40 for time slots between 16:20 and 21:00.
- 26. Participants are required to register as a CLUB ic member and present their e-membership card to get a same-day queue ticket at the entrance of the Pool. Participants aged below 18 are exempted from this requirement.



- 27. Each Participant is entitled to one same-day queue ticket daily.
- 28. Each Pool session admits up to 14 participants. Quotas are limited and available on a first come, first served basis, while quotas last.
- 29. Each ticket is valid for one participant only. All tickets cannot be resold and exchanged for cash or any other products/ offers.
- 30. Participants should follow the "Admission Time" indicated on the ticket and arrive at the venue on time. Additional time will not be given to late arrivals. Being late by more than 5 minutes will be considered as admission withdrawal, and the ticket will be deemed invalid.
- 31. Any unclaimed quota(s) in each Pool session will be released to walk-in Participant(s) 5 minutes after the session starts. Walk-in Participants are required to register as a CLUB ic member and present their e-membership card for admission. Participants aged below 18 are exempted from this requirement.
- 32. No rescheduling of the allocated session is allowed.
- 33. Parents and guardians should educate and restrict their children from performing aggressive or inappropriate behaviours including but not limited to running, jumping from the facilities, throwing any objects, littering or violating any other rules and regulations. ifc reserves the right to request any person performing the afore-mentioned behaviours to leave the Pool immediately.
- 34. No sharp or dangerous objects are allowed in the Pool.
- 35. No pets are allowed in the Pool area.
- 36. For public health and hygiene, all Participants entering the Pool shall place their shoes on the shoe rack and wear socks.

Terms and Conditions for "Joyful Slide"

- 37. To experience the Joyful Slide ("Slide"), the minimum height requirement is 100 cm and the maximum weight is 100 kg (220 lbs). Participants who do not meet the above height and weight requirements are not allowed to experience the Slide due to safety reasons.
- 38. Slide floor can accommodate up to 3 participants.
- 39. Only one participant is allowed to play the Slide at a time.
- 40. Each participant is entitled to participate in one round of the Slide at a time.
- 41. Children aged 12 or below must be accompanied and supervised by an adult aged 18 or older at all times to participate in the slide experience.
- 42. Participants are suggested to wear comfortable, casual clothing with socks. Avoid wearing skirts or dresses.
- 43. Pregnant women and participants with medical conditions that require avoidance of intense physical activities should refrain from participating in the Slide.
- 44. No sharp or dangerous objects are allowed in the Slide.
- 45. No pets are allowed in the Slide area.



Terms and Conditions for "Smile & Snap"

- 46. Participants are required to register as a CLUB ic Member and present their e-membership card to experience the instant photo taking at Smile & Snap, and receive a printed copy of their photo and/or a digital copy. Participants aged below 18 are exempted from this requirement.
- 47. Each Participant is entitled to one experience daily.
- 48. A maximum of 4 participants can take part in Smile & Snap at a time.
- 49. Each group of participants can receive a maximum of two printed copies of their photos for each participation.
- 50. Participants must abide by the Terms and Conditions for Participation and instructions advised by the staff at the Event by lightly tapping the screen with their fingers and posing for the camera to complete the experience.
- 51. Participants can use their internet-connected personal smartphones or mobile devices to scan the QR code shown on screen outside the Photo Booth to download a digital copy of their photo.
- 52. Downloading the digital copy of the photo requires the use of mobile data or a wireless network connection. The mobile network provider of participant may charge for data usage. Participants are advised to inquire with their mobile network provider for details. ifc will not be responsible for any such charges. Free Wi-Fi is available within the ifc mall, and participants agree to the terms and conditions for using the free Wi-Fi to access the mall's Wi-Fi network.
- 53. The photo(s) the Participants provide to ifc will not be used for any other purpose other than in relation to this Event and will not be transferred to any third party. The information collected will be erased in 7 days.
- 54. Children aged 12 or below must be accompanied and supervised by an adult (aged 18 or above) at all times to participate in the Photo Booth.
- 55. Limited daily quotas apply to the printed copies of photos and are available on a first come, first served basis, while stocks last. Only digital copies of photos will be available for download if the daily quota of printed copies is fully redeemed, without prior notice.
- 56. Any lost or damaged printed copy will not be redistributed.
- 57. Photos and any images of the printed copies on communication collaterals are for reference only.

Terms and Conditions for "Exclusive Soda Drinks Giveaway"

- 58. The Exclusive Soda Drinks Giveaway is held on 19 20, 25 27 July, 1 3, 8 10, 15 17, 22 24 August 2025 (every Friday to Sunday) from 11:30 14:30, or while stocks last.
- 59. Participants are required to follow one of ifc mall's social media channels (i.e. Facebook, Instagram, WeChat and RED) and post a photo with the tag of @hkifcmall and the hashtag of #ifcSummer, to receive a complimentary can of Refreshing Soda Drink ("Drink"). Participants aged below 18 are exempted from this requirement.
- 60. Each participant is entitled to receive one Drink only during the event period.
- 61. Limited daily quotas apply and available on a first come, first served basis, while stocks last.
