

## ifc mall Spring 2021 – PALACE ifc Cinema Redemption Programme

### Terms and Conditions for Participation

1. ifc mall Spring 2021 – PALACE ifc Cinema Redemption Programme (hereinafter called “Promotion”) is held from 22 February 2021 until stocks last, **Monday to Friday only** (hereinafter called “Promotional Period”) in ifc mall (hereinafter called “mall”). Valid general ifc shoppers (hereinafter called “Shopper(s)”) are eligible to participate in the Promotion.

### Terms and Conditions for Shopper(s)

2. Eligible Shopper(s) must present **TWO original same-day movie ticket stubs issued by PALACE ifc Cinema** (hereinafter called “Movie Ticket Stub(s)”) at ifc mall’s Concierge on Podium Level 1 (near Shop 1090, service hours: 10:00am - 9:30pm daily) **on the same day of movie’s show date** to receive ONE HK\$100 ifc mall Dining Voucher (hereinafter called “Dining Voucher(s)”) during the Promotional Period.
3. Photos and any images on communications collaterals are for reference only.
4. International Finance Centre Management Co., Ltd. (hereinafter called “ifc”) reserves the right to request Shopper(s) to present the relevant sales receipt, payment vouchers, corresponding credit card, EPS, Octopus, UnionPay, Alipay, Apple Pay interface, Android Pay interface and WeChat Pay interface, and/or identification documents for verification purpose.
5. ifc reserves the right not to accept and/or recognise any Movie Ticket Stub(s) which are deemed inappropriate, suspicious and/or invalid for redemption in the Promotion at its sole and absolute discretion. For any cases or suspected cases of dishonesty, ifc also reserves the right to seek assistance from the police.
6. Valid Movie Ticket Stub(s) will be stamped by ifc authorised chop after redemption. Movie Ticket Stub(s) that are not presented on the day of purchase will be regarded as invalid. Out-dated Movie Ticket Stub(s), duplicate Movie Ticket Stub(s), re-printed Movie Ticket Stub(s), damaged Movie Ticket Stub(s) and photocopied Movie Ticket Stub(s) are not acceptable. No Movie Ticket Stub is allowed to be re-used for redemption in the Promotion.
7. Each Movie Ticket Stub can only be registered for redemption once. Multiple redemptions of the same Movie Ticket Stubs are not eligible.
8. Shopper(s) to redeem the Dining Voucher(s) are responsible for inspecting the Dining Voucher(s) upon redemption. Redeemed Dining Voucher(s) cannot be returned, reissued, replaced or exchanged.
9. **Terms and Conditions for HK\$100 ifc mall ifc mall Dining Voucher(s)**
  - 9.1 HK\$100 ifc mall Dining Voucher (hereinafter called “Voucher(s)”) is applicable to participating restaurants and bars listed on [www.ifc.com.hk/media/cnydiningvoucher.pdf](http://www.ifc.com.hk/media/cnydiningvoucher.pdf) (hereinafter called “Participating Restaurant(s) and Bar(s)”). The list is subject to change without prior notice.

- 9.2 The Voucher can be used upon spending of HK\$200 or above at any Participating Restaurant and Bar. A maximum of 8 vouchers can be used in a single transaction.
  - 9.3 The Voucher is applicable to both dine-in and take-away orders at any Participating Restaurant(s) and Bar(s). Orders made through third-party food delivery platforms (including but not limited to Deliveroo, Foodpanda, Uber Eats, OpenRice) are NOT eligible for redemption.
  - 9.4 Voucher can be used once only and shall be collected upon redemption.
  - 9.5 The Voucher cannot be used in conjunction with other promotional offers.
  - 9.6 The Voucher entitles the bearer to redeem goods and services of equivalent price to its face value at the Participating Restaurant and Bar until its valid date.
  - 9.7 Any outstanding balance after deducting the face value of the Voucher must be settled by the bearer. Any unused balance will be forfeited.
  - 9.8 Please refer to the back of Voucher for the validity date. Voucher will be deemed to be invalid if it is expired.
  - 9.9 The Voucher is only valid if stamped by International Finance Centre Management Co., Ltd. (hereinafter called "ifc") for authorisation in the designated box at the back of the Voucher. Damaged or photocopied Voucher will not be accepted.
  - 9.10 Voucher cannot be redeemed for cash, or for other gift vouchers, products or services. The bearer is not entitled to any refund or exchange in cash.
  - 9.11 ifc will not accept any claim for the loss of Voucher, and will not replace any Shopping Voucher in case of loss or damage.
  - 9.12 Voucher bearer is obligated to inspect the Voucher before redemption. Redeemed Voucher cannot be returned, replaced or exchanged. The Participating Restaurant and Bar is responsible for all obligations and liabilities related to the goods and/or services provided.
  - 9.13 ifc and the Participating Restaurant(s) and Bar(s) reserve the right to amend the offer, terms and conditions without any prior notice. In case of any disputes, the decision of ifc and the Participating Restaurant and Bar shall be final.
10. All Dining Vouchers are offered on a first come, first served basis (Redeemable quantity: 2,000 pcs of HK\$100 ifc mall Dining Voucher). In the event of Dining Voucher(s) going out-of-stock, announcement will be made on ifc webpage ([www.ifc.com.hk](http://www.ifc.com.hk)) and at mall Concierge on Podium Level 1.
  11. ifc reserves the right to capture the images of Shopper(s)' Movie Ticket Stub(s) for internal control purposes. All such records will be destroyed after the completion of the Promotion. Shopper(s) who decline this arrangement will be regarded as withdrawing from the Promotion.
  12. Sales personnel of PALACE ifc Cinema is not allowed to join this Promotion or join on behalf of Shopper(s).
  13. ifc shall not be liable for any loss or damage whatsoever which is suffered (including but not limited to indirect or consequential loss) or for personal injury which is suffered or sustained, as a result of taking or using any of the Dining Voucher(s).
  14. The Promotion is bound by the above terms and conditions. ifc reserves the right to cancel, revise or suspend all or any part(s) of the Promotion, or the terms and conditions herein contained, at any time without prior notice or

reason; may (but shall not be obliged to) give advance notice to Shopper(s) in the manner it deems appropriate in such cases.

15. The decision of ifc on all matters relating to, or in connection with, the Promotion shall be final and binding on all parties concerned.
16. In case of discrepancies between the English and Chinese versions of these terms and conditions, the English version shall prevail.
17. These terms and conditions shall be construed and governed by the laws of the Hong Kong Special Administrative Region of the People's Republic of China.
