

## ifc x Shell Joint Promotion Parking 2020 Redemption Programme

### Terms and Conditions for Participation

1. ifc x Shell Joint Promotion Parking 2020 Redemption Programme (hereinafter called “Promotion”) is held from 15 June, 2020 until 31 August 2020 (hereinafter called “Promotional Period”) in ifc mall (hereinafter called “mall”). Valid general ifc shoppers (hereinafter called “Shopper(s)”) are eligible to participate in the Promotion.

### Terms and Conditions for Shopper(s)

2. Eligible Shopper(s) who spend **HK\$300 or above in a single purchase** at ifc mall can enjoy single-use 3-hour complimentary parking on the same day at either One ifc or Two ifc car park and **entitled to receive ONE set of Shell Fuels and Select Convenience Store Coupons (hereinafter called “Coupon(s)”).**

For any cases or suspected cases of dishonesty, ifc also reserves the right to seek assistance from the police.
5. Valid receipts will be stamped by ifc authorised chop after redemption. Receipts that are not presented on the day of purchase will be regarded as invalid. Out-dated receipt(s), duplicate

receipt(s), re-printed receipt(s), damaged receipt(s) and photocopied receipt(s) are not acceptable. No receipt is allowed to be re-used for redemption in the Promotion.

6. Each purchase can only be registered for redemption once. Multiple redemptions of the same transaction are not eligible.
7. Each eligible Shopper is entitled to one complimentary parking and Coupon(s) redemption per day. Any other additional same-day purchase(s) to be made subsequent to the Gift redemption are not eligible for the redemption of the day.
8. All receipts presented for Gift Redemption will not be eligible for refund. Any refund requests where receipts have been stamped by ifc will be rejected. For any cases or suspected cases of dishonesty, ifc reserves all rights to take further actions. Please refer to the validity date printed on the Coupons. Coupons will be deemed to be invalid if it is expired.
9. All Coupons are offered on a first-come, first-served basis (redeemable quantity: 110,400 pcs of Coupons), while stocks last. In the event of Coupons going out-of-stock, announcement will be made on ifc in-mall posters, ifc webpage and at ifc mall Concierge on Podium Level 1.
10. ifc reserves the right to capture the images of Shopper(s)' sales receipts and payment slips for internal control purposes. All such records will be destroyed after the completion of the Promotion. Shopper(s) who decline this arrangement will be regarded as withdrawing from the Promotion.
11. **Shell Fuels Coupon Terms and Conditions**
  - 11.1 Customers can use one coupon upon HK\$400 (net of coupon value) purchase of gasoline using a Shell Bonus Card.
  - 11.2 This coupon cannot be used in conjunction with Shell Value Card, Shell Card, or any other offer.
  - 11.3 The coupon cannot be used during special discount period.
  - 11.4 Customers can enjoy the offer of extra HK\$50 worth of the same product once by presenting this coupon.
  - 11.5 This coupon shall be redeemed at the list price. In the event that the total quantity of fuel redeemed under this coupon cannot be consumed by the customer due to the limitation of his/her fuel tank capacity, any remaining quantity of such fuel redeemed hereunder will be forfeited.
  - 11.6 This coupon and the original copy of the sales receipt will be collected after the relevant transaction.
  - 11.7 This coupon cannot be exchanged for cash or other products.
  - 11.8 Damaged, defaced, expired or photocopies of this coupon will be invalid.
  - 11.9 Shell Hong Kong Limited reserves the right to the final decision in case of disputes, and reserves the right to amend these terms and conditions without prior notice.

**12. Shell Select Convenience Store Coupon Terms and Conditions**

- 12.1 Customers can use one coupon per transaction upon HK\$50 (net of gift voucher) purchase spending in Shell.
  - 12.2 This coupon is only for entitlement of Shell Select Convenience Store purchase, coffee, lube service, and car wash service.
  - 12.3 This coupon is not applicable to gasoline products, rice, cigarettes, Shell promotion premiums, and other specified goods.
  - 12.4 This coupon cannot be used in conjunction with Shell Card or any other offers.
  - 12.5 The original copy of this coupon must be presented prior to payment and customers can get HK\$10 off instantly.
  - 12.6 This coupon and the original copy of the sales receipt will be collected after the relevant transaction.
13. Sales personnel of mall tenants are not allowed to join this Promotion or join on behalf of Shopper(s).
