Terms and Conditions for Participation

 - 15.2. When the Black Rainstorm Warning Signal is issued: If the signal is issued during Event hours, it will remain in normal operation. If the signal is issued before the Event opens, the Event will remain closed. If the signal is lowered or cancelled by the Hong Kong Observatory before or at 16:00, the Event will

resume operation in 2 hours. If the signal is lowered or cancelled after 16:00, the Event will be closed for the day.

- 16. These terms and conditions set out the guidelines for the Event to ensure all the Participants shall have a fair opportunity to access and enjoy the Event.
- 17. For Participants who fail to comply with the above guidelines, ifc reserves the right to deny admission or to require a participant already admitted to leave the site.
